

## 2018 RSTA Proposed Bylaws Amendments

### Article II—Membership

#### Current Version

#### ARTICLE II – Membership

##### SECTION 1. MEMBERSHIP –

Membership is available to any family registering a swimmer(s) upon payment of the RSTA summer season registration fee(s) with the limit of one (1) membership per family.

#### Proposed Change

#### ARTICLE II – Membership

SECTION 1. **MEMBERSHIP** – Membership is available to any family registering a swimmer(s) upon payment of the RSTA summer **or winter** season registration fee(s) with the limit of one (1) membership per family.

### Article V—Board of Directors

#### Current Version

#### ARTICLE V – BOARD OF DIRECTORS

##### SECTION 1. BOARD COMPOSITION

The Board of Directors shall be comprised of a maximum of 37 directors allocated as follows:

Three (3) directors from each of the teams participating in the RSTA League up to nine (9) directors-at-large, and the immediate past president.

#### Proposed Change

#### ARTICLE V – BOARD OF DIRECTORS

##### SECTION 1. BOARD COMPOSITION

The Board of Directors shall be comprised of a maximum of **33** directors allocated as follows:

Three (3) directors from each of the teams participating in the RSTA League up to **eight (8)** directors-at-large, and the immediate past president.

## Article VI—Officers

### Current Version

#### ARTICLE VI – OFFICERS

##### SECTION 1. SELECTION

(c) Terms—The elected term of officers shall be from the date of election until October 31 of the following year. No officer, with the exception of treasurer, shall succeed him/herself for more than two terms and in no case shall serve as an officer in any capacity for more than four (4) full consecutive terms.

### Suggested Change

#### ARTICLE VI – OFFICERS

##### SECTION 1. SELECTION

(c) Terms—The elected term of officers shall be from the date of election until October 31 of the following year. No officer, with the exception of treasurer and registrar, shall serve in the same position for more than two consecutive years. No person shall serve as an officer in any capacity for more than four (4) full consecutive terms.
